## Repertories Concordances

The project *Bernstein – The memory of paper* makes more watermark images available online than possible by the printed catalogues (repertories) together. Nevertheless, the use of the printed watermark catalogues is still necessary in many cases in order to search for identical or similar paper marks. A list of the most important printed watermark collections can be found at <http://www.ksbm.oeaw.ac.at/wz/lit/rep.htm> and in the Appendix.

Even if no identical watermark is found in any of the online Bernstein collections, the watermark under investigation can still be approximately dated because of the temporal distribution of watermarks from the same motif group. But in case the online collections contain only a small number of paper marks showing the same motif as the searched for watermark then a search in all available printed repertories becomes necessary. This applies especially to watermarks used before 1380 because most of them are found only in very few paper samples.

Hence, one of the aims of the project *Bernstein* is to make the printed repertories available online, too. This is more powerful, flexible, and advantageous than adding only references to the digital watermark catalogues with the access number of records from the printed repertories. With the integration of the repertories *Bernstein* makes all essential sources for watermark identification available online.

The two most important printed catalogues are the seventeen *Findbücher* of Gerhard Piccard and Charles-Moïse Briquet's *Les Filigranes*. The metadata to both repertories were structured and put into Excel sheets by one of the project partners – the *Laboratoire de Médiévistique Occidentale de Paris* (LAMOP). This should enable and facilitate their full integration into Bernstein. Both catalogues were scanned by the Commission of Palaeography and Codicology of Medieval Manuscripts ("Kommission für Schrift- und Buchwesen des Mittelalters") of the Austrian Academy of Sciences.

The repertory *Les Filigranes* of Charles-Moïse Briquet is already available online under: [http://www.ksbm.oeaw.ac.at/\\_scripts/php/briquet.php](http://www.ksbm.oeaw.ac.at/_scripts/php/briquet.php). A link from the Bernstein portal to this online catalogue is the only reference from Bernstein as long as the full integration of the collection of Briquet is not accomplished. A watermark can be found by the reference number or by the selection of the concerned motif. Additionally, it is possible to view all thumbnails of a motif. The names of the watermark groups in the online version of Briquet are the same as in the printed Briquet catalogue. Briquet's classification was exemplary for most of the printed watermark collections. However, Piccard created his own classification scheme – different from that of Briquet – for his collection of watermarks, which is by far the biggest in the world. Piccard's classification scheme became widely accepted in the German-speaking area.

The texts and images of the seventeen *Findbücher* of Gerhard Piccard are available in digital form, too. They will be made accessible over the Internet in the course of the year 2009. For this to happen the lists of metadata (Excel sheets) have to be proof-read first, and all the extracted watermark images have to be controlled. The software for the automatic extraction of single watermarks was developed by the project partners in Delft (DUT). In 2010 at the latest, the watermarks from the printed *Findbücher* will be linked with the corresponding motif groups in Piccard-Online.

The classification developed for Bernstein at the end of 2008 is mainly based on the classification which was introduced by Piccard for his collection and which is explained in

the first volume of the series of *Findbücher*. A direct linking of the motif groups in Bernstein with those of Briquet is not possible in many cases, because Piccard and Briquet built their watermark motif groups from different points of view.

The Bernstein project partners agreed upon the classification to be used after long and heated discussions only at the end of 2008. Hence, the integration of the Briquet catalogue and further catalogues (e.g. Likhachev) into the Bernstein portal has not been finished yet. However, this work will be continued and accomplished at the Commission of Palaeography and Codicology of Medieval Manuscripts of the Austrian Academy of Sciences within the year 2009.
